Non-Similarity Declaration

A non-similarity declaration is a document issued by FIERGS that allows importers with assets and other goods, in the absence of similar companies within the state (according to RICMS legislation addressing benefits), to obtain tax benefits related to the ICMS tax on import operations from the State Treasury Office.

Sole Manufacturer Declaration

A sole manufacturer declaration is a document issued by FIERGS attesting that the applicant company is the only manufacturer of a given product in the state of Rio Grande do Sul. The company can use this document to enjoy competitive advantages, including in relation to procurement.

FIERGS Certificate Issuing Services

Origin, Tobacco Authenticity, Free Sale and Authenticity Seals

The certificates issued by FIERGS attest to the origin of products to be exported, ensuring commercial advantages through the reduction of or exemption from taxes, in accordance with commercial agreements established in international negotiations between Brazil and other countries. In addition, the Institution also issues certificates that confirm the authenticity of tobacco, its origin, free sale in the country and authenticity seals on export documents.

FIERGS is qualified to issue the following certificates:

Certificate of Origin for the Mercosur, Chile, Bolivia, Andean Community, ALADI, India
General System of Commercial Preferences Certificate of Origin – SGPC;
Certificates of Tobacco Authenticity;
Certificates of Origin;
Certificate of Free Sale;
Authenticity Seals on export documents.
